## **Working Family Childcare Offer**

### **9 month and up 15 Hour Funding**

From September 2024 working parents in England with children aged 9 months and up will have access to 15 hours childcare. This subsidised childcare applies from the term after your child is 9 months. It is available on a term time basis for 38 weeks per year, or a stretched basis for 51 weeks per year.

This entitlement has eligibility criteria and parents/carers must ensure that this funding is applied for via the Childcare Choices website at <https://www.childcarechoices.gov.uk/>.

Please note you will need to check your eligibility every 3 months (usually before the beginning of the next term), and your unique code provided each time to the nursery for validation.

Parents/carers are responsible for the payment of any meals provided and for any additional care outside the funded session.

### **Three Year Old 30 Hour Funding**

Working parents in England can also access 30 hours of funded childcare from the term after your child's 3rd birthday. It will be available on a term time basis for 38 weeks per year, or a stretched basis for 51 weeks per year. 30 hours funded childcare has eligibility requirements and parents/carers must ensure that funded free hours are applied for via the Childcare Choices website at <https://www.childcarechoices.gov.uk/>.

Please note you will need to check your eligibility every 3 months (usually before the beginning of the next term), and your unique code provided each time to the nursery for validation.

Parents/carers are responsible for the payment of any meals provided and for any additional care outside the funded session.

## **3-Year Funding - 15 hours funded free childcare**

You will be entitled to 15 hours per week of funded childcare from the term after your child's 3rd birthday. This subsidised childcare is available for all children and is not means tested. Please ask us for application information for 15 hours of funded free childcare.

## **2-Year Funding for Families in Receipt of Benefits**

If you are receiving one of the following benefits, your 2-year-old should be entitled to Early Years Funding. This will commence the term after they are two:

- Income Support (IS)
- Income Based Job Seekers Allowance (IBJ)
- Child Tax Credit, provided you are not entitled to Working Tax Credit and have an annual income that does not exceed £16,190
- Guaranteed element of State Pension Credit
- Employment and Support Allowance (ESA)
- Support under part VI of the Immigration and Asylum Act 1999.
